Instructions for filling up the tender and terms & conditions

1. Properly sealed quotations should be submitted in the office of the undersigned either in person or by the registered post on or before 31/07/2018 till 12:00 noon quotations received after due date & time, will not be accepted.
2. Self attested photocopy of GST, Registration certificate, IT clearance certificates of atleast three financial years, PAN/TAN No. (with proof) must be submitted along with the quotations, failing which claim will be rejected.
3. Price must be quoted F.O.R. at Dighi, Dumka inclusive of all charges and equipments/apparatus should be such ISI certified.
4. Price must be valid for one year from the date of issuing work order.
5. Payment will be made after the receipt of goods in good conditions, certified by the concerned departments regarding satisfactory performance.
6. All items must be delivered within 15 (Fifteen) days from receipt of order.
7. The party quoting should have a minimum experience of 10 years in the field of scientific apparatus supply and should have annual turnover of 2 crore and above.
8. The bidder should have the authorisation from manufacturer in case of the agency, if not being the manufacturer.
